This section explains how to docket an Objection to Debtor's Intent to Cure Back Rent.

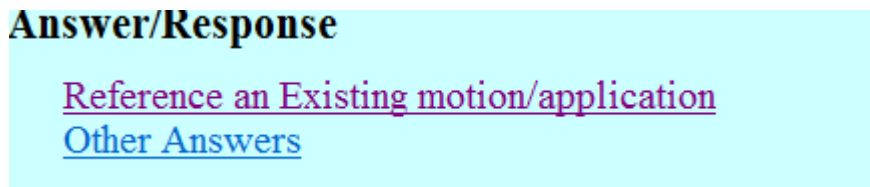
Step 1 Click **Bankruptcy** on the Main Menu Bar.



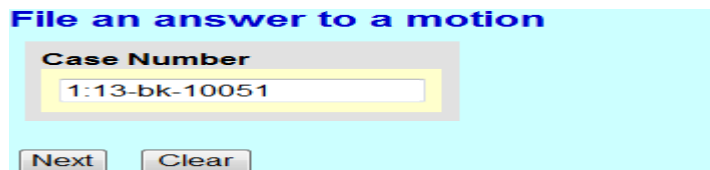
Step 2 Select the **Answer/Response** Category.
