

Official Form B121 Statement of Social Security

To keep the debtor(s) social security number private, you must docket the B121 form using the correct event which has been designed to be a private event. Only by using this event will the public be restricted from seeing the debtor(s) information.


Step 1 Click **Bankruptcy** on the Main Menu Bar




Step 2 Select the **Other** Category
