

Statements of Monthly Income
or
Means Test, Disposable Income or Current Monthly Income Statements

Under the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005, certain individual debtors are required to file Statements of Monthly Income documents.

Non business debtors must file the following documents under the following chapters:

- Chapter 7 Form B122A-1 or "Means Test"
- Chapter 7 Form B122A-1 Supplement
- Chapter 7 Form B122A-2 Means Test Calculation
- Chapter 13 Form B122C-1 or "Disposable Income"
- Chapter 13 Form B122C-2 Calculation of Disposable Income
- Chapter 11 Form B122B Statement of Monthly Income

Regardless of the chapter, each of these documents can be filed as separate document, as an attachment or as part of the petition. To file as a separate document follow the steps below.




Step 1 Click **Bankruptcy** on the Main Menu Bar.
