- Disability or incapacity: Before describing any medical conditions or filing additional documents supporting a purported disability or incapacity, see Fed.R.Bankr.P. 9037 and Local Bankruptcy Rule 9018-1 for filing options.
- 3. <u>Military Service</u>: Disclosure of military service should not in any way compromise the safety of the debtor or others, *see* Local Bankruptcy Rule 9018-1 for filing options.
- 4. <u>See 109(h)(4)</u>: A description of "incapacity" and "disability" as it applies to this waiver request is found in 11 U.S.C. Section 109(h)(4).
- 5. The motion must be served on the case trustee and the United States Trustee.
- 6. <u>Certificates of service</u>: *See* Local Bankruptcy Rule 9013-3(c) for requirements. The motion may be denied if service is not proper.
